**Precautionary Statements**

### 4. FIRST AID MEASURES

<b>Inhalation:</b>	Move to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention.

### 5. FIRE FIGHTING MEASURES

**Clean-up methods:**

Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder, sawdust). Scrape up spilled material and place in a closed container for disposal. ## 7. HANDLING AND STORAGE

**Handling:**
