#### 4. First-aid measures

#### 5. Fire-fighting measures

#### 6. Accidental release measures

<b>Methods and materials for containment and cleaning up</b>	Refer to attached safety data sheets and/or instructions for use. Stop leak if you can do so without risk. ## 7. Handling and storage

### Precautions for safe handling

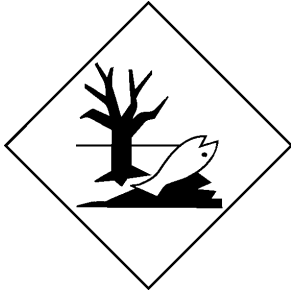
